

Return and Refund Policy

Thank you for shopping at Most Pacific. If, for any reason, You are not completely satisfied with a purchase We invite You to review our policy on refunds and returns. The following terms are applicable for any products that You purchased with Us.

Interpretation

The words of which the initial letter is capitalized have meanings defined under the following conditions. The following definitions shall have the same meaning regardless of whether they appear in singular or in plural.

Definitions

For the purposes of this Return and Refund Policy:

Company- (referred to as either "the Company", "We", "Us" or "Our" in this Agreement) refers to Most Pacific.

Goods- refer to the items offered for sale on the Service.

Orders- mean a request by You to purchase Goods from Us.

Service- refers to the Website.

Website- refers to Most Pacific, accessible from <http://www.mostpacific.com>

You- refers to the individual accessing or using the Service, or the company, or other legal entity on behalf of which such individual is accessing or using the Service, as applicable.

Your Order Cancellation Rights

You are entitled to cancel Your Order within 14 days without giving any reason for doing so.

The deadline for canceling an Order is 14 days from the date on which You received the Goods or on which a third party you have appointed, who is not the carrier, takes possession of the product delivered and the date it was said delivered by courier.

In order to exercise Your right of cancellation, You must inform Us of your decision by means of a clear statement.

We will reimburse You no later than 14 days from the day on which We receive the returned Goods. We will use the same means of payment as You used for the Order, and You will not incur any fees for such reimbursement.

Conditions for Returns

In order for the Goods to be eligible for a return, please make sure that:

The Goods were purchased in the last 14 days

The following Goods cannot be returned:

The supply of Goods made to Your specifications or clearly personalized.

The supply of Goods which according to their nature are not suitable to be returned, deteriorate rapidly or where the date of expiry is over.

The supply of Goods which are not suitable for return due to health protection or hygiene reasons and were unsealed after delivery.

The supply of Goods which are, after delivery, according to their nature, inseparably mixed with other items.

We reserve the right to refuse returns of any merchandise that does not meet the above return conditions in our sole discretion.

All Items posted "FINAL SALE" will not be refunded.

Only regular priced Goods may be refunded. Unfortunately, Goods on sale(reduced price) cannot be refunded. This exclusion may not apply to you if it is not permitted by applicable law.

Returning Goods
